Maximizing Out-of-School Time

- ✓ Provides afterschool and/or summer programs
- ✓ Provides safe and positive environments
- ✓ Provides the most inclusive and least restrictive environment where all children can be successful
- ✓ Enhances academic achievement
- ✓ Supports social and physical development
- ✓ Strengthens children's relationships with adults and peers



Desired Population: Inclusion



- ✓ Serves children of all abilities
- ✓ Ages 5--12 (or enrolled in 5th grade)
- ✓ Must attend a public school (District or Charter) on the Priority School List
- ✓ OR live within the attendance boundary of a Priority School

Priority School List details to be included in RFP

Desired Population: Special Needs



- ✓ Ages 3 up to, and including, 21 years old
- ✓ Documented physical, developmental, or behavioral health diagnosis
- ✓ Must reside in Broward County



Priority School List not applicable

Applicant Requirements: Broward County Child Care Licensing and Enforcement



All programs operating during the school year **MUST** be licensed or exempt through the Broward County Child Care Licensing and Enforcement Section (CCLE) and comply with all background screening and fingerprinting requirements.

Applicant Requirements: School Sites



Before and After School Child Care (BASCC) Eligibility

- ✓ Must apply and be approved under BASCC *"Child Care Services – Before and/or After School, Summer, and Non-School Day Programs"*
- ✓ MUST identify the proposed site(s)
- ✓ Principal Authorization Letter for each site required *(Principal Authorization Letter does not guarantee the provider will be selected to serve the school)*

Applicant Requirements: Community Sites



- ✓ MUST identify proposed site(s)
- ✓ MUST have authorization/approval (*Memorandum of Agreement*) to provide services at the site

Applicant Requirements: Fiscal

- ✓ Budgets(s) required with proposal submission
- ✓ Agencies must demonstrate financial solvency by utilizing the financial viability test
 - Agencies with annual revenue greater than \$500,000 will provide an audit conducted in accordance with generally accepted auditing standards (GAAS).
 - Agencies with annual revenues less than \$500,000 may submit unaudited Financial Statements reviewed by a CPA
- ✓ **All applicants are strongly encouraged to review the Fiscal Viability Test and apply it to their most recent audit prior to submitting an application.**
- ✓ The test can be found on Children's Services Council of Broward County website (cscbroward.org):

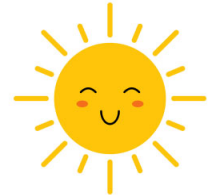

Inclusion Supports with Navigation Services Application for Funding (AFF)

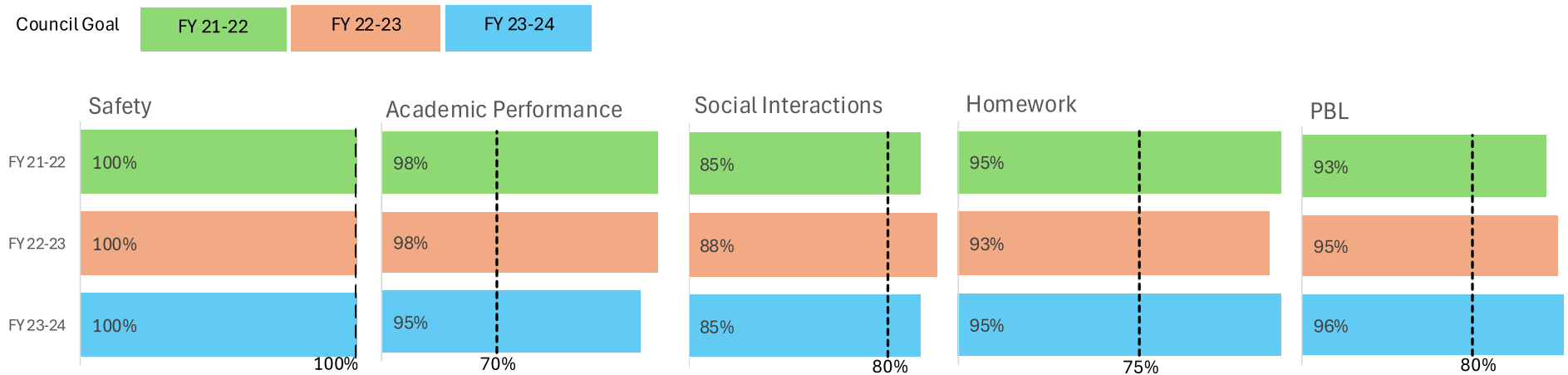
Inclusion Supports provides expertise in best practices to strengthen our community's capacity to deliver high-quality, inclusive programs for children with disabilities.

Short-Term Navigation Services being explored



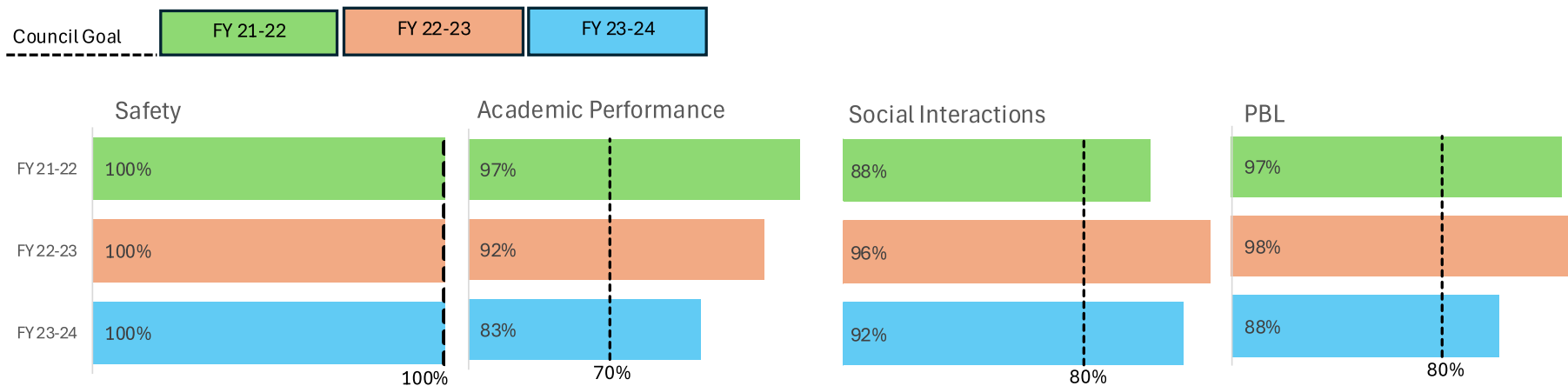
Performance Measures: Inclusion

All performance measures met or exceeded Council Goal.



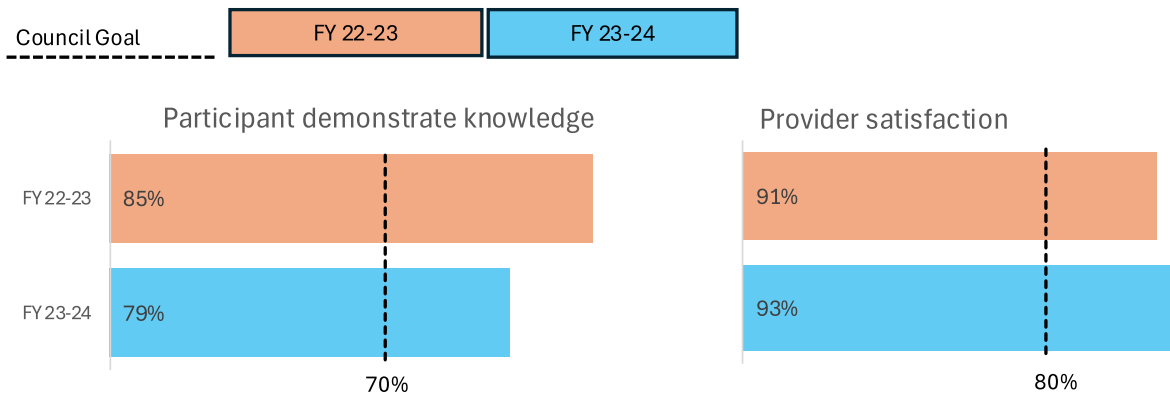
Performance Measures: Special Needs

All performance measures met or exceeded Council Goal.



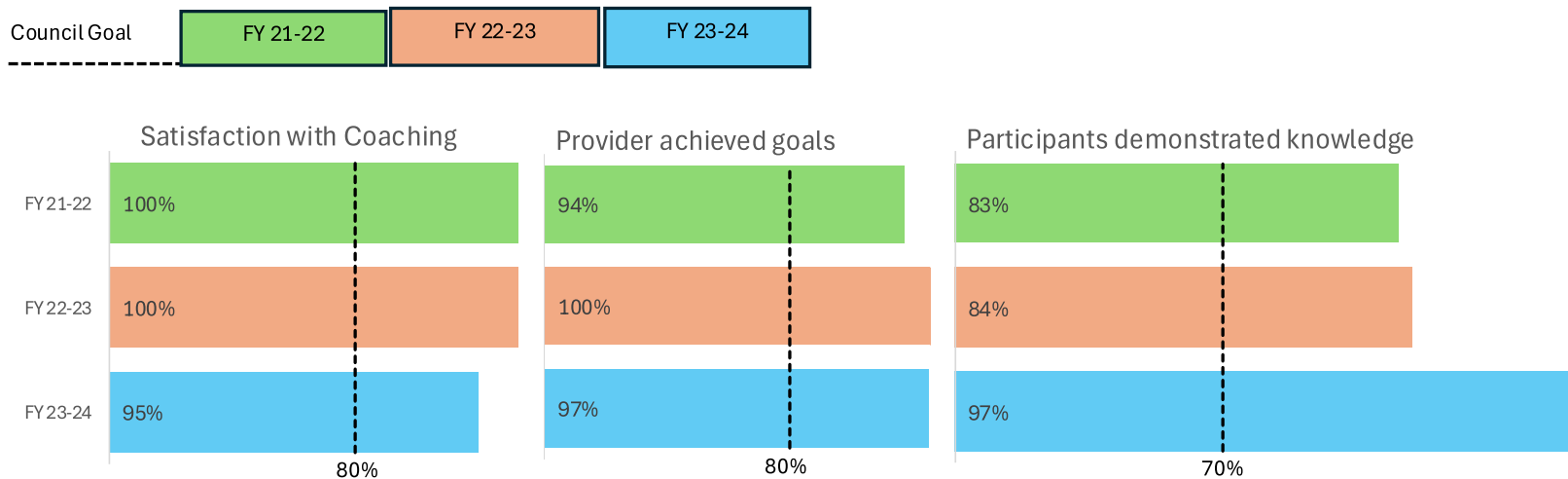
Performance Measures: CATCH
